
Exhibit A- Preliminary Master Plan

PRELIMINARY MASTER PLAN ELEMENTS

A preliminary diagrammatic site plan was developed based upon the group diagrammtic plan concepts developed in the community workshop. Major elements are located in relation lto each other to maximize site potential and diversity of facility user groups.

Two alternative options were developed for the aquatics facility (see Exhibit K - Master Plan - Aquatic Center Option 1 on page 36 and Exhibit L - Master Plan - Aquatic Center Option 2 on page 37). Along with the preliminary maste rplan, a potential phasing plan has been developed that allows for organized development and minimize disturbance to park users and neighboing communities (see Exhibit M - Possible Phasing Plan on page 38).



CONSENSUS ITEMS

Aquatic Building

· Located at the same place it currently resides.

Badminton

Located on the west side of the park, next to other additional courts.

Baseball Field

Located in the southeast corner of the park site, where it currently resides.

Basketball Court

• Located on the west side of the park, next to additional courts.

Gazebo

Located at the parks high point to provide vista opportunities.

Parking

• Enhancing the existing parking and improving traffic and pedestrian access to the rest of the park site.

Picnic Area

· Refurbish existing picnic areas to current standards and improve accessibility.

Restroom

Located near the basketball courts, multi-use field, and pool.

Soccer

Overlay field located in the southeast corner of the park site.

Splash Pads

• New splash pads located in the pool area.

Tennis Courts

• Located on the west side of the park, near the other courts.

Tot Lot

• Centrally located in the middle of the park under the canopy of the existing trees.

Volleyball

• Located on the west side of the park, near the courts.
