Project Description:

- 1. Demo existing Auditorium Wood flooring and dispose of material
- 2. Installation Robbins 25/32 XL Strip Maple flooring or equivalent
- 3. Apply one (1) coat of Bona DTS Sealer or equivalent
- 4. Apply two (2) coats of Bona Super Sport Finish or equivalent
- 5. Install new Johnsonite vent cove base, or equivalent, at walls

Contractor's License:

The successful bidder will be required to possesses a valid California State Contractor's license at the time the Contract is awarded.

Prevailing Wage Requirement:

The successful bidder will be required to pay Federal prevailing wage rates in effect 10 days prior to the bid deadline. Copies of those prevailing wage rates are included with the original bid packet received from ARPD. If the prevailing wage rates have changed 10 days prior to the bidding deadline, the new wage rates will be distributed to all contractors that have provided contact information to ARPD. Failure to receive addenda or updated wage information due to nonexistent or incorrect contact information may render a bidder non-responsive.
